

## LANDSCAPING II: HARDSCAPE AND NON-PLANT FEATURES

Introduction to Landscaping II Certificate includes a sequence of courses that provide a foundational understanding of irrigation systems, greywater systems, and storm water capture systems, irrigation as part of landscape design, and non-plant features that are part of landscape design.

### REQUIRED CORE COURSES: You MUST complete these three courses!

#### **ADLTED 722:** Workplace Arithmetic--Part 2

Instruction in basic operations with decimals, fractions, percents and conversions related to trades and industries. (18-hour course)

#### **ADLTED 742.1:** Hardscaping 1: Irrigation

Non-plant landscaping with emphasis on industry-specific terminology related to water use. (40-hour course)

#### **ADLTED 742.2:** Hardscaping 2: Non-plant Features

Intro to the different types of hardscaping non-plant features such as walls, pathways, fences, seating, decks, and pergolas. (40-hour course)

### SAFETY REQUIREMENT: You MUST complete this course!

#### **ADLTED 740:** OSHA 10 Preparations

A general awareness in recognizing and preventing hazards on a job site. (12-hour course)

### REQUIRED ELECTIVE COURSES: You MUST complete one of these courses!

#### **ADLTED 746:** Building Plan Reading

Intro to reading and interpreting construction plan views, section cuts, elevations, and details for construction purposes. (40-hour course)

#### **ADLTED 748.5:**

#### Introduction to Sprinkler Repair and Maintenance

Intro to the basics of irrigation systems focusing on repairing sprinklers and damaged lines; raising, lowering, and relocating sprinkler heads; troubleshooting the main assembly. (24-hour course)

#### **ADLTED 748.6:**

#### Landscape Equipment Operations

Students will learn about pre-operation, operation, and post-operation maintenance of a variety of commonly used types of landscape equipment. (48-hour course)


